## Available Scholarships

### 1040K Run/Lewis Davis Scholarship

Three awards available and based on; 1) academic achievement, 2) financial need and, 3) involvement in FICPA and/or community volunteer activities. At least one scholarship will be awarded to an African American student; one to a minority student (may or may not be African-American) and one based on financial need.  
*See also "County Residency" requirement.*

**ELIGIBILITY:** Applicants must be at least a 4th-year Senior AT TIME OF APPLICATION. Applicants must attend one of the following seven schools to apply: Barry Univ.; FLA Atlantic Univ.; FLA Int'l Univ.; Keiser Univ.; Nova Southeastern Univ.; St. Thomas Univ.; Univ of Miami.

**SCHOLARSHIP AMOUNT:** \$3,000

**APPLICATION DEADLINE:** February 11, 2020

**FUNDS AWARDED:** April 27, 2020

### James Wilcox Endowment Scholarship

Funds restricted to assisting African-American students solely with 5th- year or Masters tuition. Four awards available, two male and two female recipients.

**ELIGIBILITY:** For students at least a senior AND to be enrolled in 5th year or Master's courses by fall Semester, 2020

**SCHOLARSHIP AMOUNT:** \$5,000

**APPLICATION DEADLINE:** March 13, 2020

**FUNDS AWARDED:** Fall, 2020

### FICPA Scholarship Foundation Scholarship

Eligible students are invited to apply for more than \$130,000 in available 2020 scholarships. Number of scholarships vary by school and based upon each institution's accounting program enrollment.

**ELIGIBILITY:** For students at least a junior AND to be enrolled in 4th or 5th year by fall Semester, 2020

**SCHOLARSHIP AMOUNT:** \$2,000

**APPLICATION DEADLINE:** March 13, 2020

**FUNDS AWARDED:** Fall, 2020

### Walter A. Friedly Memorial Scholarship

Three awards available to students from following Universities: FLA Atlantic Univ. (FAU); FLA State Univ. (FSU); Univ. of FLA (UF).

**ELIGIBILITY:** For Students at least a junior AND to be enrolled in 4th or 5th year by fall Semester, 2020

**SCHOLARSHIP AMOUNT:** \$2,000 (Varies annually)

**APPLICATION DEADLINE:** March 13, 2020

**FUNDS AWARDED:** Fall, 2020

### REQUIRED FOR ALL:

- Membership in Florida Institute of CPAs (FICPA). FICPA Student Membership is free, join at [ficpa.org/join](http://ficpa.org/join).
- Submission of OFFICIAL Transcript & Faculty Recommendation Form

- Citizen of the U.S. OR hold permanent residency status AND shall be Florida resident
- Degree-seeking Florida accounting major
- Enrolled in accredited accounting program
- Planning to sit for CPA exam in Florida

- Desire to practice accounting in state of Florida upon graduation
- Minimum GPA Requirement of 3.0 cumulative & accounting GPAs (upper division 3000 or above - Official Transcript also required)
- Maximum # lifetime scholarships awards per student: Up to (2) consecutive awards
